

**KFRG/KXFG/KVFG CONTEST RULES**  
**K-FROG QUAD GIVEAWAY**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.**

1. **HOW TO ENTER**

- a. The K-Frog Quad Giveaway Contest (the "Contest") will begin on May 9<sup>th</sup>, 2008 at 5am Pacific Time ("PT") and end on May 15<sup>th</sup>, 2008 at 5pm PT (the "Contest Period").
- b. To participate in the Contest, you must enter via the following method: Enter at <http://www.kfrog.com> beginning at 5am PT on May 9<sup>th</sup>, 2008, by completing the entry form on the home page. Enter your first name and last name, complete address, city, state, zip code, home telephone number and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address. Multiple participants are not permitted to share the same email address. All entries submitted become the sole property of KFRG and will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by KFRG. KFRG's computer is the official timekeeping device for this Contest.
- c. All entries must be received by Thursday, May 15<sup>th</sup>, 2008 by 5pm Pacific Time to be eligible for the Contest.
- d. KFRG is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.

2. **ELIGIBILITY RESTRICTIONS**

- a. The Contest is open to all persons who are eighteen (18) years of age or older and who reside in the Greater Southern California Area, including: the Inland Empire, Los Angeles, Orange County, High Desert and Temecula Valley areas. Employees of The K-Frog Radio Network (KFRG/KVFG/KXFG) (the "Stations"), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Southern California metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. Subject to all applicable federal, state, and local laws and regulations.
- b. A listener may win only one K-Frog contest every 30 days. Only one winner per household is permitted in any Stations contest.

- c. Contest winner will be required to sign a participant release of liability and hold a valid California Drivers License.
- d. Contestants are required to provide truthful information and the Stations will reject and delete any entry that it discovers to be false or fraudulent. The Stations will disqualify any entry from individuals who do not meet the eligibility requirements, and the Stations will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3. PRIZES

- a. One (1) Grand Prize will be awarded. The Grand Prize is a New, 2007 400cc TOMOTO ATV with a retail value of \$3800.00. Prize Winner will be solely responsible for any applicable vehicle titles, licenses and registration fees, freight, delivery, dealer prep, emissions inspection, additional equipment, all federal, state and local taxes, insurance, gasoline, vehicle maintenance, all other fees and expenses not specified herein associated with the receipt and use of this prize vehicle. Any additional vehicle options not specified herein are subject to availability and will be the responsibility of the Winner. In the event that the winner is not able to obtain valid automobile insurance or does not hold a valid driver's license, the winner will forfeit the prize vehicle and will not be awarded a cash or prize alternative and an alternate winner will be selected in a random drawing of all remaining eligible entries received. **[Specify arrangement for pick-up of ATV]**
- b. All prizes or prize certificates may be picked up at the office of the Stations at the address below. The winner will forfeit any prize or prize certificate not claimed by Friday, May 16<sup>th</sup>, 2008 at 5pm. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Stations are not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. Prize Winner must take Prize "as is". The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of Stations management with respect to the Contest are final.
- b. Winner will be selected via a random drawing from all eligible internet entries received and announced on-air on Friday, May 16<sup>th</sup>, 2008 at approximately 8am Pacific Time by the Frogmen In the Morning. Odds of winning depend upon the number of on-line entries received.
- c. Winner need not be present or listening to win.
- d. Odds of winning depend on the number of eligible entries received.

- e. Winner will be notified by Stations Management immediately following the drawing. If winner does not return the notification attempt within 3 days, and also execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form by Monday, May 18<sup>th</sup>, 2008 at 5pm, prize will be forfeited, and an alternate winner will be chosen in a random drawing of all remaining eligible entries received.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. For any prize valued at \$600 or above, winner will be required to sign an IRS Form W-9 or the equivalent or prize will be forfeited..
- b. By participating in the Contest, the winner agrees to have their name, voice, or likeness used in any advertising or broadcasting material relating to this Contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Stations in its sole discretion may require Contest winner to sign a liability release, agreeing to hold the Stations, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.
- d. The Stations, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Stations' Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. The Stations reserve the right to make changes in the rules of the Contest, including the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Stations, the Fastest Frogman in the Morning race is delayed, rescheduled, postponed or cancelled, the Stations reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- f. Failure to comply with the Contest rules may result in a Contestant's disqualification solely at the discretion of the Stations.
- g. The Stations are not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
